- All monetary denotation will only be in Ringgit Malaysia (“**RM**”).

Shell

- Cardholders who make payment using the Card will be rewarded RM5 cashback with a minimum spend of RM60 in a single receipt upon checkout (“**Eligible Transaction**”).
- For the avoidance of doubt, the Eligible Transaction includes spend on petrol (at both outdoor payment terminals and indoor cashier counters) and any spend only in Shell Select stores.
