

## TERMS AND CONDITIONS – G-SHOCK 2.0 WITH SHELL PROMOTION 2019

1. The G-SHOCK 2.0 WITH SHELL PROMOTION 2019 (“Promotion”) is jointly organized by Shell Malaysia Trading Sdn Bhd (Company No. 6087-M) (“SMTSB”) and Shell Timur Sdn Bhd (Company No.113304-H) (“STSB”), collectively known as “Shell”.
2. The Promotion Period is from 1 SEPTEMBER 2019 to 31 OCTOBER 2019, both dates inclusive, which can be extended by Shell without prior notice.
3. This Promotion is open only to all Shell customers in Malaysia who are not less than 21 years old (“Participants”) at all Shell Retail Stations in Malaysia except for the following categories of persons:
  - (a) Permanent and/or contract employees (“Employees”) of Shell and its Affiliates and their immediate family members i.e. spouses, children, parents, brothers and sisters (“Immediate Family Members”);
