

## **LIMITED EDITION SHELL MOTOSPORTS COLLECTIBLES 2022 – TERMS AND CONDITIONS**

1. The Limited Edition Shell Motorsports Collectibles 2022 Promotion (“Promotion”) is jointly organized by Shell Malaysia Trading Sdn Bhd (Company No. 6087-M) (“SMTSB”) and Shell Timur Sdn Bhd (Company No. 113304-H) (“STSB”), collectively known as “Shell”.
2. The Promotion Period is from 8 October 2022 (12:01 AM) to 8 December 2022 (11:59 PM) both dates inclusive, which can be amended by Shell without prior notice.
3. The Promotion is available to all Shell customers in Malaysia (“Customers”) and is available at all Shell Retail Stations nationwide.

  - (a) Shell Motorsport Car Models;
  - (b) Bluetooth Battery pack; and

The Ferrari F1 car and battery pack are available throughout the Promotion Period. The Limited-Edition Collector's Case will be available throughout the Promotion Period. All whilst stocks last.
